Shri Gajanan Shikshan Prasarak Mandal's Toshniwal Arts, Commerce and Science College, Sengaoon Dist. Hingoli (hereafter referred as TACSCS) and Swami Vivekanand Senior College, Mantha Dist. Jalna (hereafter referred as SVSC) wish to sign memorandum of understanding (hereafter referred as MoU) on today 10th Jan 2020 for Academic Cooperation in the form of faculty exchange, knowledge cooperation through internal quality assurance cell (IQAC).

1. About TACSCS:

TACSCS established during June 1993 with the motive to provide education to the then downtrodden society located at this hilly, backward area, the institute is 2(f), 12(B) approved by UGC New Delhi, Govt of Maharashtra and affiliated to SRTM University, Nanded. Now a day the institute provides UG as well as PG education to students of Arts, Commerce and Science faculty.

2. About SVSC:

SVSC is an institution established and governed by Marathwada Sarvodaya Shikshan Prasarak Mandal Partur, the institution is the Institute is 2(f), 12(B) approved by UGC New Delhi, Govt of Maharashtra and affiliated to Dr BAM University, Aurangabad catering the education at different levels of UG and PG.

Purpose and Scope of MoU

The purpose of signing this MoU is to provide academic cooperation of either side by supporting faculties through internal quality assurance cell (IQAC) in the form of academic cooperation for quality sustenance and quality culture development and knowledge sharing. Whereas it is expected to execute this MoU for following points in reciprocal manner:

Academic expert guidance	Understanding of theory quality culture enrichment
Use of ICT in quality development	Organization of training programme
Support for institutional development	

3. Resources exchange

TACSCS and SVSC will examine the possibility of exchange of some technical expertise in the field of quality culture enrichment understanding of either to support the faculty of reciprocal academies, which could include resources and staff etc.

4. Funding:

This MoU does not include the exchange of funds between the two parties; the cost generated for any activity would be bare by the party itself.

5. Record Retention:

Records generated out of the activities would be used and retained by both parties as per their requirements and needs with mutual consents of each other.

6. Mere understanding

This MoU only represents a basis of understanding between TACSCS and SVSC towards one or more formal agreement as may be executed by the institutions. It is clarified that this MoU does not constitute an agreement and therefore is not enforceable as an agreement.

7. Arbitration clause

If any dispute persisted regarding any aspects of academic cooperation, Principal, TACSCS and Principal, SVSC will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

8. Term and termination

- This MoU shall remain in force for an initial period of five (5) years from the date of signing unless its validity is renewed for a further period mutually agreed by both institutions.
- This MoU may be terminated/renewed at any time by either institution with/without mutual consent.

9. Signed in duplicate

This MoU is executed in duplicate with each copy being an official version and having equal legal validity. By signing below, the institutes acting by their duly authorized officer, have caused this MoU to be executed, effective as of the day and year first above written.



MEMORANDUM OF UNDERSTANDING

For Academic and Scientific Co-operation

Between

DEPARTMENT OF BOTANY,

SWAMI VIVEKANAND SENIOR COLLEGE, MANTHA DIST. JALNA, MAHARASHTRA

And

**NUTRIMIST MUSHROOM RESEARCH AND TRAINING CENTRE (NMRTC),
AURANGABAD, MAHARASHTRA**

PURPOSE

Purpose of this agreement is to promote cooperation in education and scientific research between Department of Botany, Swami Vivekanand Senior College, Mantha Dist. Jalna and Nutrimist Mushroom Research and Training Centre, Aurangabad for Skill Development and Outcome Based Training.

TYPES OF COOPERATION

1. Joint research projects in the field and mutual interest.
2. Exchange academic publications and reports.
3. Practical training to Swami Vivekanand Senior College Students.
4. Organization of joint workshop and training.
5. NMRTC, Aurangabad may depute its personnel as a visiting faculty at Swami Vivekanand Senior College to teach any of regular course or specialized topic.
6. NMRTC may seek assistance/guidance of SV College faculty member/s in product/process modification, modernization, trouble shooting, etc.
7. NMRTC would allow the visits of SV college students for half/full day to provide them with an exposure to various equipment, instrument, etc.
8. Other activities as mutually agreed.

EFFECTIVE DATE AND DURATION OF MOU

1. This agreement will become effective from the date of signature by both parties.
2. It shall remain valid for the period of five (05) years from the date of last signature, with understanding that it may be modified by written mutual consent of both parties.
3. This agreement may be terminated by either party with advance written notice of at least thirty (30) days. Upon notice of termination both parties SV Sr. College, Mantha and NMRTC are agree to work in good faith to enable visiting students to complete their respective research programmes unhindered by the termination.
4. Agreement may be extended by mutual consent of the two parties after the five (05) years period and it must be renewed in writing.

AMENDMENTS

Any amendment and/or addenda to the agreement shall be in writing and signed by the parties hereto and shall only after such execution be deemed to form part of the agreement and have the effect of modifying the agreement to the extent required by such amendment or addenda.

This Memorandum of Understanding completed in English is hereby signed in two (02) copies with one (01) copy remaining in the possession of each institution.
